

EUROTECH relocates to new headquarters



Eurotech Vertriebs GmbH is a medium-sized company that offers a comprehensive range of vacuum components as well as complete handling and transport solutions. Products also include both serial and customer-specific lifting devices, tube lifters and vacuum-based solutions for automated handling tasks that are individually adapted to the requirements of customers.

THE NEW BUILDING

Founded in 1996 in Rosenfeld by Peter Bunnenberg, the specialist for vacuum, lifting and transport technology has been based in

Geislingen since 2001. Gradually, additional levels were rented in the main building. But despite the expansion of the top floor and the rental of a hall in Balingen, the spatial limit has long been reached and, because no suitable rental space was found, Eurotech

Eurotech Vertriebs GmbH relocated to its new site in Rosenfeld in May. The company has invested EUR 3.65 million in this new building, while the state of Baden-Württemberg contributed more than EUR 400,000 in funds from the ELR and EFRE development programmes to the project.

decided to build a new one. Official groundbreaking took place on 4 May 2020, in the Rosenfeld industrial area Dornbrunnen, where new production and storage areas as well as a two-story administration building have been built. The advantages are obvious: In addition to resource and energy efficiency, the new building also offers a lot more space. Thus, it enables optimal conditions for healthy and sustainable growth.

Twelve months later, the production and warehouse spaces (2,245 square metres) and a two-storey administration building (740 square metres) located at Maybachstraße 7 are now finished. The specialist for vacuum technology's around 40 employees have now also relocated to their modern space at the 7,740 metre site.

"With this investment, Eurotech is taking another important step towards a successful future," emphasizes Thomas Schulz, Managing Director of the medium-

sized enterprise. "We have had to expand our physical capacities to keep up with the increased requirements of our industry and the large volume of orders we have been receiving."

RETURNING TO ITS ROOTS WITH RESOURCE- AND ENERGY-EFFICIENCY

Eurotech is, in this way, returning to its roots in Rosenfeld, with this new building, which not only offers significantly more space, but also has fast access to the A 81 motorway

and is extremely resource- and energy-efficient: Constructed as a KfW 55 low-energy house, the building only needs 55 per cent the amount of electricity compared with a reference building according to the German Energy Conservation Regulation (EnEV). Streamlined workflows and no longer having to transport materials between Geislingen and Balingen has resulted in an efficiency boost of approximately 20 per cent. Above all, the new headquarters sets

the Swabian company on a path towards healthy, sustainable growth.

Eurotech received assistance for its new building from the state of Baden-Württemberg. Its funding scheme 'Spitze auf dem Land! Technologieführer für Baden-Württemberg, Ländlicher Raum' in the development programme supports the development and economic utilisation of new products and services. The construction project was planned and managed by Bau Cooperation in Offenburg.
