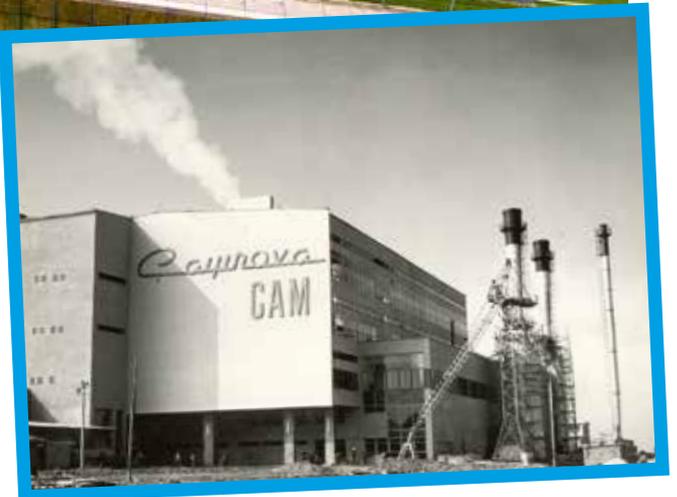


From national pioneer to global leader: ŞİŞECAM's 90-year story

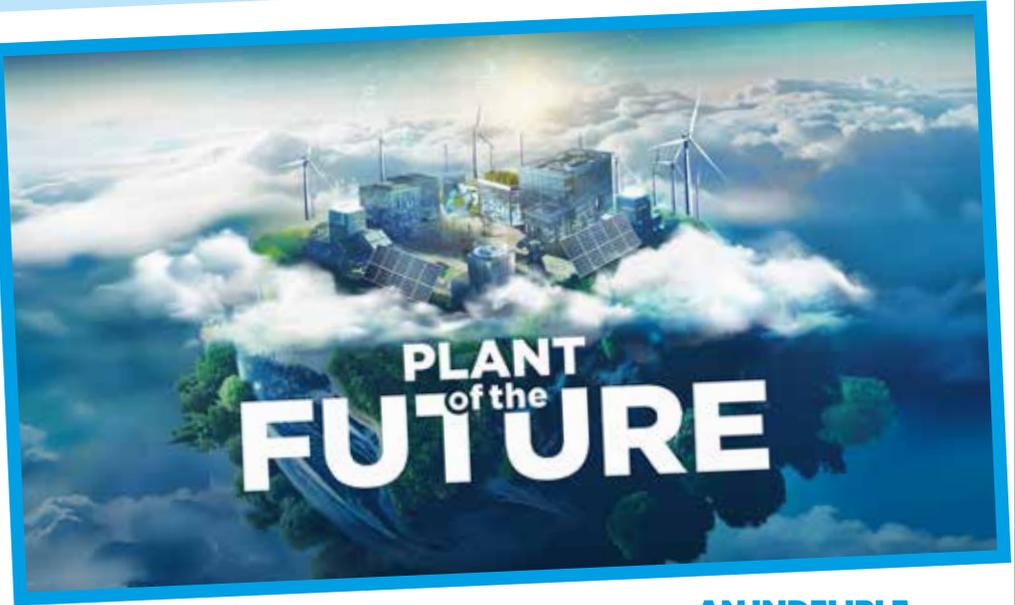

AN INDELIBLE LEGACY THROUGH TIME

With the decision of the Council of Ministers, the task of establishing the Turkish glass industry was assigned to Turkey İş Bankası by Atatürk.

- The Paşabahçe Factory began production on 4 July 1935 with 400 employees.
- It was officially inaugurated on 29 November 1935 by Prime Minister İsmet İnönü.
- In 1961, Paşabahçe received its first export request from the USA, with products shipped overseas within a month.

As a worldwide company operating across all core areas of glass production, Şişecam is a global leader in glassware and chromium chemicals, ranking among the top five producers in flat glass and glass packaging, and is one of the two largest soda ash producers globally. Operating across four continents and 14 countries -including Turkey, Germany, Italy, Bulgaria, Romania, Slovakia, Hungary, Bosnia and Herzegovina, Russia, Georgia, Ukraine, Egypt, India and the United States- Şişecam plays a pioneering role in the flat glass, glassware, glass packaging, chemicals, auto glass, glass fibre, mining, energy and recycling industries. With innovation and technology at its core, the company serves customers in over 150 countries through a robust supply chain. With 90 years of expertise, a highly-skilled workforce and smart technologies, Şişecam now continues its journey of growth. Supported by over 24,000 employees, the company moves steadily toward its goal of becoming one of the top three global producers in its core industries. Under its CareForNext strategy, Şişecam is dedicated to ensuring the sustainability of the glass and chemicals industries by protecting the planet - empowering communities and transforming lives in line with the United Nations Sustainable Development Goals. ing flat glass in Turkey in 1959 and glass packaging in 1967. Soda Sanayi was established in 1969.

- In 1976, Şişecam founded Turkey's first corporate R&D centre.
- The company was publicly listed on the Istanbul Stock Exchange on 13 January 1986.
- Its first overseas investment took place in 1997 in Georgia, in the field of glass packaging.
- In the early 2000s, it expanded into Egypt, Bulgaria, Russia, and Italy.
- In 2011, Şişecam launched 'Glass and Glass Again,' one of Turkey's most comprehensive sustainability and social responsibility initiatives, promoting glass recycling.
- That same year, it contributed to education by

establishing the Vocational School of Technical Sciences at the Mersin Tarsus Organized Industrial Zone, fostering industry-education collaboration.

- In 2019, it completed the construction of the Şişecam Yenisehir Vocational and Technical Anatolian High School, and in its 90th year, it will continue supporting education with new school projects in Lüleburgaz and Tarsus.
- In 2017, Şişecam launched its sustainability vision under the CareForNext initiative.
- In the late 2000s, it continued its global investments in Italy, India, Hungary, Slovakia, Egypt, and Romania.
- In 2019, Şişecam made its first soda ash production investment in the USA.
- In 2020, on its 85th anniversary, Şişecam unified all operations under "One Şişecam."
- In 2024, to shape the production technologies of the future, Şişecam launched the Plant of the Future platform, inviting all stakeholders to participate. That same year, it acquired full ownership of its soda ash operations in the USA, bringing it closer to global leadership in soda ash production.
